

Re: Complaints against judges involved in the infamous Waterkloof four case

Dear Mr Justice Langa:

I write to you today to inform you of my intentions as well as my utter disappointment in the blatant failures of the judiciary.

I see myself as a professional person and in that capacity I have tried to communicate my concerns to the JSC and by extension the Judges involved only to be met by delusions of grandeur and blatant ignorance. How could a person even begin to describe a judicial system where a provincial president issues a written statement asserting that it is irrelevant when judges are wrong? I believe that it is very relevant when judges are wrong and from the recent headlines I gather that some part of you agrees with me.

On numerous occasions I have asked for explanations about the process of my complaints. I have asked when it would be reviewed. I have asked whether the JSC is taking these complaints seriously given that the said Judges does not seem to. All I wanted was an explanation of how the Judges could come to the conclusions that they did given the evidence entered into court. My complaints were lodged professionally and with care not to attack people personally and

still I was treated with contempt. This ends today. I can no longer stand by and accept that a questionable institution like this is supposed to protect my rights.


I am a staunch critic of the media, but thanks to my recent experiences I have come to appreciate their value a great deal. I am taking my story to the public. I want to ask South Africa if they think that it is irrelevant when a Judge is wrong. Although I believe that pardons will be handed out like food vouchers after the elections, I still think that it is important that South Africans know what they have created.

Regarding the case in question, it would be a mistake to assume that my lack of legal experience disqualifies me from making a logical argument. If I erred in my findings it would have taken an experienced Judge no time to prove me wrong, but regrettably they chose to laugh the matter off. In light of this I have decided to add more credibility to my findings. This case is currently being reviewed by a legal scholar and the findings as well as subsequent actions will be shared with everybody. I am adamant that the truth must be exposed. I will not allow this injustice to be buried.

Four young men are wrongfully incarcerated by the very people tasked with protecting their rights. This can not be allowed and I believe that South Africa will agree with me once they learn the truth. I am of the opinion that every Judge involved in this matter failed to uphold the oath that they took before God on entering office and in that alone they are completely unfit to hold any office in the Judiciary.

The shame is not in being wrong, it is in refusing to correct yourself when you realise it.
